December 7, 2019: India's leading fruit drink player, Manpasand Beverages Ltd. has reported revenue during the FY 2018-19 of Rs. 636 Crores vis-à-vis Rs. 955 Crores. Net loss before exceptional items and tax stood at Rs. 206 Crores for the year ended March 31, 2019 as against net profit of Rs. 117 crore in the previous fiscal year.

The performance has to be viewed against extra-ordinary events faced by the company during the last eighteen months. Operational performance has been hampered due to significant amount of time and effort expended by the management in addressing all issues with respect to regulatory authorities and other vested shareholder groups.

Despite these exigencies, company is readying the operational facilities at Vadodara, Ambala and Varanasi for the forthcoming summer season propelled by the confidence of the vendors and distributors.

Other Highlights of FY18-19:

- Through continuous dialogue with distributors, they have reposed faith and confidence in the management across India-2000 distributors and 5 lac retailers
- The ten-year joint distribution agreement with Parle Products continues and will help to expand its distribution reach across India.
- The construction work at Sri City, Andhra Pradesh company's first plant in the southern region has been hampered and likely to be reassessed.
